1. Sandag - Regional Comprehensive Plan

Susan Baldwin, Sandag, presented a powerpoint presentation on the Regional Comprehensive Plan that captured the history of population and transportation growth over 20 years.

ORAL COMMUNICATIONS:

This portion of the agenda provides an opportunity for members of the public to address the City Council on items relating to City business and not appearing on today's agenda by submitting a speaker slip to the City Clerk (located on the back table). Comments relating to items on this evening's agenda are taken at the time the items are heard. Pursuant to the Brown Act, no action shall be taken by the City Council on public comment items. Items can be referred to the City Manager for placement on a future agenda. The maximum time allotted for each presentation is THREE MINUTES as per SBMC . (Be aware of the timer lights on the Council dais.)

Claudia Carillo, SDGE, stated that in order to meet peak demand small actions would be required to reduce current energy usage and she suggested ways to conserve energy.

Vicki Cypherd displayed a sign that was nailed to a palm tree that advertised German Shepherds and asked what the policy was for signs posted.

David Ott, City Manager, stated signs are prohibited on all public property including the right of way and suggested that residents report it to Code Enforcement to handle and to not remove the sign themselves.

- 4. Professional Services Agreement for Federal Legislative and Administrative Beach Shoreline Advocacy Issues. (File No. 0400-10)
 - A. Adopt Resolution 2007-089 authorizing the City Manager to execute Amendment No. 5 to the Marlow & Co. Agreement for Federal Legislative and Administrative Beach Shoreline Advocacy Issues extending the existing agreement for one year not to exceed \$4,350 a month.

MOTION: Moved by Roberts and seconded by Campbell . **Motion carried unanimously.**

PUBLIC HEARINGS continued: (Items 5-9)

This portion of the agenda provides citizens an opportunity to express their views

on a specific issue as required by law after proper noticing by submitting a speaker slip to the City Clerk (located on the back table). After considering all of the evidence, including written materials and oral testimony, the City Council must make a decision supported by findings and the findings must be supported by substantial evidence in the record. An applicant or designee for a private development/business project, for which the public hearing is being held, is allotted a total of fifteen minutes to speak, as per SBMC 2.04.210. A portion of the fifteen minutes may be saved to respond to those who speak in opposition. All other speakers have three minutes each. Please be aware of the three-minute timer light on the Council Dais.

5. Fiscal Year 2007-08 Resolution of City Fees. (File No. 0390-20)

- A. Receive report
- B. Adopt Resolution 2007-067 establishing a schedule of fees and charges for City services.

Steve Didier, Management Analyst, presented a PowerPoint presentation.

Eric Johnson, RCS (Revenue and Cost Specialists), reviewed the methodology used to determine the proposed cost of City services.

Mayor Heebner opened the public hearing.

Walter Oliver asked if the new business certificate initial fee would affect all contractors such as window washers, handy people, and businesses who may only have one client in Solana Beach, that the fee would be passed onto their customers, that there were other ways to generate recovery of costs such as an increase in vacation rentals, and suggested that Council look at it further.

Council discussion ensued regarding that fact that all cities charge a fee for all business certificates and licenses, confirmed that the fee of the initial business certificate would be \$70.00 for a landscaping company that is a registered business or incorporated who has only client once a week, that kids cutting yards would not be assessed the fee, and that the line has to be drawn somewhere.

Gordon Johns said that the Budget and Finance Committee supported the fee study and that the fee increases would get the City on track for cost recovery after 10 years of inattention.

MOTION: Moved by Roberts and seconded by Nichols to close the public hearing. **Motion carried unanimously.**

MOTION: Moved by Roberts and seconded by Campbell . **Motion carried unanimously.**

Council discussion continued regarding yard services, that it was a public safety issue to be aware of who is doing business in Solana Beach, fee waivers, and the difference in fees for resident and non-resident programs based on other cities' standards.

- 6. Adoption of the Fiscal Year (FY) 2007-08 Solid Waste Rate Increase for EDCO Waste and Recycling Services. (File No. 1030-15)
 - A. Adopt Resolution No. 2007-091 approving EDCO's rate review request increasing commercial solid waste rates for FY 2007-08 in accordance with the Franchise Agreement.

MOTION: Moved by Campbell and seconded by Roberts to close the public hearing. **Motion carried unanimously.**

Mayor Heebner opened the public hearing.

Angela Ivey, City Clerk, reported that there were no majority protests received and there were not any speakers that requested to address the item.

MOTION: Moved by Campbell and seconded by Roberts . **Motion carried unanimously.**

- 7. Adoption of the Fiscal Year (FY) 2007-08 Solid Waste Rate Increase for Coast Waste Management. (File No. 1030-15)
 - A. Adopt Resolution No. 2007-090 approving Waste Management rate review request increasing residential solid waste rates from current \$18.30 per month to \$19.02 per month for FY 2007-08 in accordance with the Franchise Agreement.

MOTION: Moved by Roberts and seconded by Campbell to close the public hearing. **Motion carried unanimously.**

David Ott, City Manager, restated the purpose of the increase at this time due to the normal billing cycle having already past.

Mayor Heebner opened the public hearing.

MOTION: Moved by Roberts and seconded by Campbell . Motion carried

unanimously.

- 8. A request for a Development Review Permit and a Structure Development Permit to demolish an existing single-family residence and construct a new single-family residence with 2,480 square feet of gross floor area on a property located at 354 Pacific Avenue, Solana Beach (Case: 17-07-05 DRP/SDP; Applicant: Cenci Properties, LP). (File No. 0600-40)
 - A. Continue the matter to the July 11, 2007 Council meeting.

- 9. A Request for a Development Review Permit and Structure Development Permit to construct a new two-story residence with a basement and associated grading on a vacant lot at 134 South Granados Avenue (Case No.: 17-06-33; Applicants: Tim & Ann McCormick). (File No. 0600-40)

Council and staff discussion ensued regarding setting public hearing for July 11th, that Mayor Heebner and Councilmember Nichols would assess the Coastal Rail Trail's tree and landscaping status, and to obtain organic material subsidized by SDG&E.

10.5 Condo-Hotel. (File No. 0610-10)

A. Give Staff direction as to whether to process a regulatory ordinance to develop a ban of the condo-hotel ownership method for hotels in the Commercial Zone or allowing for restrictions on condo-hotel uses.

MOTION: Moved by Roberts and seconded by Nichols move forward with process to ban. **Motion carried unanimously.**

Council and staff discussion ensued regarding condohotels being too complex of an issue for small city, that land is scarce and should be used for other things, how to enforce, prohibiting the fractional use of these properties, that the City Attorney will review all zoning and general plan issues for any conflicts, that a prohibition would be presented in a public hearing and the CEQA process, that the City may be the first to prohibit rather than impose restrictions, that it would be more of an inforcement issue than the City could provide for, that the Local Coastal Plan should be included in a prohibition, and that the City could take a leadership role in this issue, and the concern of how they affect the immediate community.
