SB 1186 Fee Senate Bill (SB) 1186 (Chapter 383, Statutes of 2012) created Government Code Section 4467. This statute was recently amended by Assembly Bill 1379 (Chapter 667, Statutes 2017). Among other things, this statute requires: January 1, 2018, through December 31, 2023, a four-dollar (\$4.00) additional fee is to be paid by any applicant for a local business license, permit or similar instrument when it is issued or renewed.						
The issuance of a business certificate shall not be deemed as evidence that a person, association, organization, institution, firm or corporation operating a business in the City is in fact in compliance with all ordinances, rules or regulations of the City or that they have applied for, or have been issued all permits or licenses which otherwise may be required. Contact the Community Development Department at 858-720-2440 for information on zoning use restrictions, planning permits, and building permits which may be applicable and required prior to operation of the business.
