

BUDGET AND FINANCE COMMISSION SUMMARY MINUTES Special Meeting Monday, April 8, 2024 - 6:00 P.M. Solana Beach Mayor's Conference Room 635 S. Highway 101, Solana Beach, CA 92075

1. Call To Order And Roll Call:

Chairperson Lyle called the Budget and Finance Commission (Commission) Meeting to order at 6:03 p.m. on April 8, 2024.

2. Oral Communications - Public:

4. Approval of Meeting Minutes – January 22, 2024

5. FY2023 Annual Comprehensive Financial Report (ACFR)

Finance Director Rachel Jacobs presented the FY2023 Annual Comprehensive Report presentation. Director Jacobs reported that there was a positive net change of \$2,998,764 in the general fund. She also reported on the general fund reserves, other governmental funds, and the proprietary funds. The Commission members asked for a comparison of the FY 2023 fund balances to FY 2022. Director Jacobs answered questions relating to the PARS and OPEB funds and then asked if there were any more questions on the CAFR. The Commission members had no more questions.

6. FY2024 Mid-Year Budget Update

Finance Director Rachel Jacobs presented the FY 2024 Mid-Year Budget Update. Director Jacobs reported that with the proposed budget changes to revenues and expenditures, the new projected general fund surplus was \$946,047. She answered questions regarding the STVR revenue and explained the HDL reports used to project sales tax and property tax revenues. Chairperson Jeff Lyle introduced the topic of Measure S, and Director Jacobs went over the current status of Measure S for the newest member, Commission member Larry Marmon. Director Jacobs asked if there were any other questions, and there were none.

7. City Manager Roundtable

There was no City Manager Roundtable.

The meeting was adjourned at 7:15 pm.
