Mayor Heebner opened the public hearing.

David Ott, City Manager, introduced the item.

Marie Berkuti, Finance Manager, presented a PowerPoint (on file) .

Council and Staff discussed the calculation of the triple flip deduction that balanced out, the bonds are being paid off this next year and there was an overlap gap when they the projection was being made, that there was about 250k surplus, that pending employee negotiations would possible use some of that, the administrative funding for the former RDA (Redevelopment Agency) that may be reduced, that there would be some remaining funds of the surplus, some costs are staffing and some for legal, and that the City Manager was confident in the projection based on the 2016-17 sales tax projection.

Discussion continued regarding the irrevocable trust for PERS that was not technically part of the budget would be planned for an August meeting to determine the funding and investment portfolio

Terry Decker stated that he was the Solana Beach School District Superintendent, introduced himself, and thanked Council for support of safety measures.

**Motion:** Moved by Zito and second by Marshall to close the public hearing. **Motion carried unanimously.**

**Motion:** Moved by Zito and second by Marshall to approve with the added intention to address reallocations of certain funds for a trust for investing funds for future PERS funding. **Motion carried unanimously.**
