

BACKGROUND:

Unified Communication (UC) systems are the convergence of voice and data networks, advancing digital communication tools, and increasing the effectiveness of mobile devices. It addresses the inefficiencies of managing separate communication channels by integrating various tools like voice calls, email, instant messaging, and video conferencing into a unified platform. Cloud computing has further facilitated the deployment of UC solutions. Today, UC is essential for organizations, promoting seamless communication, collaboration, and adaptability in a dynamic work environment.

The City's current phone system operates on an on-premises model, with various components managed by the Information Technology (IT) department. These components include end-user phone hardware, call processing, setting up of extensions or direct-inward-dialing (DID) connections, voicemail, interactive voice recording (IVR), and the management of phone-line providers. Additionally, the servers supporting these critical functions are either reaching or have already reached the end-of-life support phase, posing potential risks and limitations to the system's performance and security. To address these challenges, Staff initiated a Request for Proposals (RFP) and selected a qualified vendor, Salient Networks, that is capable of delivering a reliable, integrated communication solution.

This item is before the City Council to consider approval of Resolution 2024-107 (Attachment 1) authorizing the City Manager to execute an Agreement for Unified Telecommunications Services with Salient Solution.

DISCUSSION:

Since the City's phone system is on-premises, there are limitations to its capabilities. Upgrading the City's phone system from Cisco's Call Manager to the cloud offers scalability, flexibility, and cost efficiency over time. Cloud-based systems reduce upfront capital expenses associated with purchase of equipment, allow easy scalability, and support remote work. Automatic updates, disaster recovery, and enhanced features for the environment are additional benefits. Maintenance overhead is reduced as tasks are outsourced. The cloud enables seamless

integration with other services and is more efficient, allowing the City to consolidate the voicemail vendor (Xmedius), phone system support (Salient), phone service provider (AT&T – CalNet), Paging/Broadcasting (Quicklert) and call center system (Akaddian). Overall, this migration enhances efficiency, reduces costs, and enhances communication for the City.

Staff performed a needs assessment and developed the RFP to retain specified services that can meet the City's current and future needs. These services involve upgrading and consolidating the telephone system into a cloud-based service. The RFP for these service needs was advertised for a total of four (4) weeks. Staff advertised on August 25, 2023, and provided the RFP to all service providers that it could identify that may be capable of performing the work. Five (5) service providers submitted proposals: CallTower, NTS Communications, Salient Solutions, Spectrum, and Vonage. Below we have provided a cost breakdown as identified by each service provider.

During the evaluation of the proposals submitted, CallTower was initially selected as the toprated vendor based on the panel's assessment of their cost-effective solution. However, after further negotiations, CallTower was unable to meet key contract terms related to service level agreements and implementation timelines, which resulted in their disqualification. As a result, City staff has chosen to recommend the second-rated vendor, Salient Networks. While Salient Networks' proposal had a higher cost compared to CallTower's, they offer a similar solution and have demonstrated the ability to meet all contract requirements.

In addition to their compliance with all contract requirements, Salient Networks brings a distinct advantage due to their long-standing partnership with the City. Over the course of several years, Salient Networks has consistently demonstrated their in-depth knowledge of our telecommunications infrastructure, ensuring seamless integration and minimal disruption during system upgrades. Their familiarity with the unique nuances of our network architecture, operational needs, and technical environment positions them to deliver a highly efficient and customized solution. This expertise will not only expedite the implementation process but also ensure superior long-term support, minimizing future downtime and optimizing system performance. Given their proven track record and strong understanding of the City's technology landscape, Salient Networks is uniquely qualified to deliver this critical telecommunications upgrade.

Pursuant to Solana Beach Municipal Code (SBMC) section 3. 08. 140, because of their unique nature, it is in the best interest of the public, as allowed by state law, that contracts for professional services such as computer consultants, engineers, or other professional or

consultant services of a similar nature, or at the discretion of the purchasing officer, be selected on the basis of demonstrated competence and on the professional qualifications necessary for the satisfactory performance of the services required, negotiated between parties rather than on the basis of cost alone. Therefore, the City is not limited to awarding professional services contracts to the lowest responsible bidder, but rather on the basis of demonstrated competence and qualifications for the types of service to be performed at a fair and reasonable price.

The RFP for these service needs were advertised for a total of four (4) weeks. Staff advertised on August 25, 2023, and provided the RFP to all service providers that it could identify that may be capable of performing the work. Five (5) service providers submitted proposals: CallTower, NTS Communications, Salient Solutions, Spectrum, and Vonage. Staff provided a cost breakdown of each service provider above.

The proposed agreement with Salient Networks will streamline and consolidate several services currently provided by multiple vendors, resulting in significant cost savings for the City. Currently, the City incurs approximately \$67,000 in annual expenditures from the IT General Fund (100-5450) for the following services and vendors: voicemail services (Xmedius), phone system support (Salient), phone service provider (AT&T – CalNet), paging/broadcasting system (Quicklert), and call center system (Akaddian).

By transitioning to a single, comprehensive solution provided by Salient Networks, these vendors will be phased out, reducing the City's overall expenditures. This consolidation is expected to generate an estimated annual savings of \$67,000. These savings will offset the cost of the new agreement in future fiscal years, ensuring that the consolidation will not only enhance operational efficiency but also remain fiscally responsible for the City.

In addition to their compliance with all contract requirements, Salient Networks brings a distinct advantage due to their long-standing partnership with the City. Over the course of several years, Salient Networks has consistently demonstrated their in-depth knowledge of our telecommunications infrastructure, ensuring seamless integration and minimal disruption during system upgrades. Their familiarity with the unique nuances of our network architecture, operational needs, and technical environment positions them to deliver a highly efficient and customized solution. This expertise will not only expedite the implementation process but also ensure superior long-term support, minimizing future downtime and optimizing system performance. Given their proven track record and strong understanding of the City's technology landscape, Salient Networks is uniquely qualified to deliver exceptional service.

Staff is recommending that Council authorize the City Manager to execute an agreement with Salient for 3 years with two 1-year allowable extensions.

CEQA COMPLIANCE STATEMENT:

Not a project as defined by CEQA.

FISCAL IMPACT:

The total cost of the agreement is \$225,839.88 for 3 years with two 1-year allowable extensions. The impact of this agreement for Fiscal Year 2024/25 will be \$24,583.98, as is outlined below. There is sufficient fund balance available in the IT Asset Replacement Budget.

As mentioned above, this agreement will consolidate the costs associated with other services/ vendors originally proposed for FY 2024/25 budget. The costs associated with the City's voicemail vendor (Xmedius), phone system support (Salient), phone service provider (AT&T – CalNet), Paging/Broadcasting system (Quicklert), and call center system (Akaddian) result in nearly \$67,000 of expenditures to the IT General Fund (100-5450) per fiscal year. Therefore, the cost reduction to the IT General Fund Budget (100-5450) due to consolidation of services/ vendors are sufficient to cover the expense of this agreement in each future Fiscal Year.

WHEREAS, upgrading the City's phone system to the cloud offers scalability, flexibility, and greater efficiency; and

WHEREAS, pursuant to Solana Beach Municipal Code (SBMC) section 3. 08. 140, because of their unique nature, it is in the best interest of the public, as allowed by state law, that contracts for professional services such as computer consultants, engineers, or other professional or consultant services of a similar nature, or at the discretion of the purchasing officer, be selected on the basis of demonstrated competence and on the professional qualifications necessary for the satisfactory performance of the services required, negotiated between parties rather than on the basis of cost alone. Therefore, the City is not limited to awarding professional services contracts to the lowest responsible bidder, but rather on the basis of demonstrated competence and qualifications for the types of service to be performed at a fair and reasonable price; and

WHEREAS, to improve the current phone system, the purchasing officer determined and City Council confirms that it is in the best interest of the public that a service provider be selected pursuant to SBMC 3.08.140. City Staff developed a needs assessment, prepared a Request for Proposal (RFP) dated August 25, 2023, and advertised for selection of a unified communications service provider. The RFP was posted and distributed to all service providers that Staff was able to identify and allowed for a duration of 4 weeks to submit proposals, resulting in submissions from five service providers; and

WHEREAS, City Staff carefully evaluated all proposals and originally selected the proposal submitted by CallTower, however CallTower could not meet the City's contractual terms ; and

WHEREAS, City Staff seeks to contract with the proposal that came in second, Salient Networks. Salient Networks' proposal demonstrates competence and the professional qualifications necessary for reliable performance of the services required by the City. Further, Salient Network represents the most efficient solution among all proposals received; and

WHEREAS, funding for a unified communications system is available in the Information Technology Asset Replacement Fund Balance.

NOW, THEREFORE, the City Council of the City of Solana Beach, California, does resolves as follows:

- 1. That the above recitations are true and correct.
- 2. That Salient Networks has demonstrated competence and the professional qualifications for the reliable performance of the services required by the City.
- 3. The proposal submitted by Salient Networks has been evaluated as offering the most efficient solution among all the proposals received.
- 4. That the City Council authorizes the City Manager to execute an Agreement with Salient Networks for unified communication services at a total contract amount not to exceed \$225,839.88 during an initial 3 year term with two 1-year allowable extensions.
- 5. That the City Council authorizes the City Treasurer to amend the Fiscal Year 2024/25 Adopted Budget by increasing Information Technology Asset Replacement Account 1355450.66400 by \$24,583.98 utilizing their available fund balance.



BACKGROUND:

The City of Solana Beach (City) is eligible to apply for Federal Community Development Block Grant (CDBG) funding administered locally through the County of San Diego Department of Housing and Community Development (County). The County has recommended that the City target Americans with Disabilities Act (ADA) improvements to improve the accessibility and safety for persons living with disabilities, which is one of the CDBG goals. The City Council has approved previous annual CDBG applications to construct ADA compliant pedestrian ramps at public street intersections throughout the City.

For the upcoming application, Staff prepared for Council's consideration a new list of street intersections that may be improved with ADA compliant pedestrian ramps (Attachment 1, Exhibit A). This item is before the City Council for the consideration of Resolution 2024-106 (Attachment 1), which would approve the list of ramps and authorize Staff to apply for the Fiscal Year (FY) 2025/26 CDBG funding program.

DISCUSSION:

The County has indicated that the City's anticipated CDBG funding will be approximately \$52,814 for this annual grant application. Staff developed a list of locations consistent with the anticipated funding. The ramps listed in Attachment 1, Exhibit A, are at locations either with no existing pedestrian ramp or with an existing ramp that does not meet current standards. All ramps are located along the right of way segments identified in the City's

CITY COUNCIL ACTION:

Safe Routes to School Program. The number of ramps to be constructed will be adjusted to match the available funding. Since this possible Council action has been advertised as a public hearing, any information, comments, and testimony received on this item will be attached to this report and sent to the County along with the City's application.

CEQA COMPLIANCE STATEMENT:

This project is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301(c) of the State CEQA Guidelines.

FISCAL IMPACT:

There is no impact to the General Fund due to the use of Federal CDBG Funds. Staff anticipates that the City will receive CDBG funding of approximately \$52,814 for FY 2025/26. Staff will program the funds for the ADA pedestrian ramps in the proposed FY 2025/26 CIP Budget.

BACKGROUND:

This item is before the City Council to consider adoption of Ordinance 537 which would prohibit the sale and distribution of kratom (krat-um) to persons under 21 years old in the City. If adopted, Ordinance 537 would add Chapter 6.40 to the Solana Beach Municipal Code and include enforcement mechanisms to prohibit the sale and distribution of kratom to persons under 21 years old throughout the City.

DISCUSSION:

Kratom products are derived from the Mitragyna speciosa tree in Southeast Asia, where the leaves of the plant are chewed and brewed in teas. The effects of ingesting kratom have been tied to chemical compounds found in the plant that contain mitragynine and 7- hydroxymitragynine. These chemicals can produce a broad range of effects on the user including psychotic symptoms, psychological and physiological dependence, addiction, hallucinations, delusion, confusion, nausea, itching, sweating, dry mouth, constipation, increased urination, loss of appetite, anorexia, weight loss, and insomnia. Its effects have been described as both a stimulant in low doses and a sedative in high doses.

Kratom products typically come in greenish powders, capsules and extracts, and are readily found in smoke shops and online. Synthetic versions of Kratom are also readily available. Because Kratom is not regulated at the federal level or by the State of

California, there is a wide variety of products with different levels of potency creating potentially hazardous situations for users of all ages.

The U. S. Drug Enforcement Administration ("DEA") has labeled kratom a "Drug and Chemical of Concern" which are substances not currently controlled by the Controlled Substances Act, but pose risks to individuals who abuse them.

Roughly 2 million Americans use kratom, often to self-treat conditions without medical supervision, despite FDA warnings that kratom is not appropriate for medical use or for use as a dietary supplement and has been found to be associated with serious health risks.

The FDA has not approved any prescription or over-the-counter drug products containing kratom or its two main chemical components, mitragynine and 7-hydroxymitragynine, which pose a high risk of abuse and can be found in higher doses in synthetic kratom products.

On April 12, 2019, the U.S. Center for Disease Control and Prevention ("CDC") published a report, "Notes from the Field: Unintentional Drug Overdose Deaths with Kratom Detected - 27 States, July 2016 - December 2017," which states that: (1) kratom use has recently increased in the United States where it is usually marketed as a dietary or herbal supplement; (2) studies suggest that kratom has the potential for creating user dependence and abuse; and (3) reports have documented several overdose deaths involving kratom.

Kratom products are not federally regulated in the United States and are not subject to government-mandated safety standards, resulting in a lack of oversight and accountability for safe use, regulation of ingredients, purity levels, and dosage.

States and local governments have prohibited the sale or possession of kratom within their respective jurisdictions including, but not limited to, the cities of San Diego and Newport Beach, and the states of Alabama, Arkansas, Indiana, Rhode Island, Vermont, and Wisconsin. Some states have prohibited the sale or possession of kratom by persons under the age of 21, including Colorado, Florida, Louisiana and Oregon. The City of Solana Beach does not currently regulate the sale or distribution of kratom in the City.

The full effects of kratom are not entirely clear, but research is continuing. In the meantime, this unregulated substance is available to individuals of all ages without restriction or safety standards. The proposed ordinance attached hereto aims to completely abolish the sale and distribution of kratom to persons under the age of 21 in the City.

OPTIONS:

1) Approve and Adopt Ordinance 537 as drafted.

- 2) Approve and Adopt Ordinance 537 with modifications.
- 3) Provide other direction to Staff related to kratom regulation.

CEQA COMPLIANCE STATEMENT:

The proposed City Council action is not subject to the California Environmental Quality Act (CEQA) pursuant to the CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, Sections 15060(c)(2) and 15060(c)(3) because it will not result in a direct or reasonably foreseeable indirect physical change in the environment and is not a "project," as defined in Section 15378 of the CEQA Guidelines.

FISCAL IMPACT:

There are no direct fiscal impacts related to this item. There will be some additional costs associated with implementation related to enforcement; however, due to the limited number of establishments selling these products, the enforcement time would be relatively minimal in the scope of overall Code Enforcement Staff and Sheriff's staff resources.

Staff recommends the City Council adopt Ordinance 537 adding Chapter 6.40 to the Solana Beach Municipal Code to prohibit the sale and distribution of kratom products to persons under the age of 21.

ORDINANCE 537

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SOLANA BEACH, CALIFORNIA, ADDING CHAPTER 6.40 TO THE SOLANA BEACH MUNICIPAL CODE TO PROHIBIT THE SALE AND DISTRIBUTION OF KRATOM TO PERSONS UNDER THE AGE OF 21

WHEREAS, the U. S. Drug Enforcement Administration ("DEA") has stated that consumption of kratom produces both stimulant effects (in low doses) and sedative effects (in high doses), and can lead to psychotic symptoms, psychological and physiological dependence, addiction, hallucinations, delusion, confusion, nausea, itching, sweating, dry mouth, constipation, increased urination, loss of appetite, anorexia, weight loss, and insomnia, and has labeled kratom a "Drug of Concern;" and

WHEREAS, the U. S. Food and Drug Administration ("FDA") has stated that an estimated 1.7 million Americans used kratom in 2021, often to self-treat conditions without medical supervision, despite FDA warnings that kratom is not appropriate for use as a dietary supplement, and has been found to be associated with serious health risks including, but not limited to, seizures, vomiting, liver problems, physical dependence, substance abuse disorder, and neonatal abstinence syndrome in which newborns exposed to kratom prior to birth experienced withdrawal signs such as jitteriness, irritability, and muscle stiffness, and even death; and

WHEREAS, the FDA has not approved any prescription or over-the-counter drug products containing kratom or its two main chemical components, mitragynine and 7hydroxymitragynine, which pose a high risk of abuse and can be found in higher doses in synthetic kratom products; and

WHEREAS, on April 12, 2019, the U. S. Center for Disease Control and Prevention ("CDC") published a report, "Notes from the Field: Unintentional Drug Overdose Deaths with Kratom Detected - 27 States, July 2016 - December 2017," which states that: (1) kratom use has recently increased in the United States where it is usually marketed as a dietary or herbal supplement; (2) studies suggest that kratom has the potential for creating user dependence and abuse; and (3) reports have documented several overdose deaths involving kratom; and

WHEREAS, kratom products are not federally regulated in the United States and are not subject to government-mandated safety checks, resulting in a lack of oversight and accepted safety standards for use, regulation of ingredients, purity levels, and dosage; and

WHEREAS, states, local governments, and municipalities have prohibited the sale or possession of kratom within their respective jurisdictions, including but not limited to, the cities of San Diego and Newport Beach, and the states of Alabama, Arkansas, Indiana, Rhode Island, Vermont, and Wisconsin; and

WHEREAS, in the interest of the health, safety, and welfare of the people of the City of Solana Beach, the City Council desires to prohibit the sale and distribution of any product containing kratom to any person under the age of 21 within the jurisdiction of the City; and

WHEREAS, Title 6 of the Solana Beach Municipal Code contains health and safety procedures for the City of Solana Beach.

The City Council of the City of Solana Beach, California, ordains as follows:

SECTION 1. All of the above recitals are true and correct and are incorporated herein as findings.

SECTION 2. The adoption of the ordinance is not subject to CEQA pursuant to Section 15060(c)(2) and 15060(c)(3) of the State CEQA Guidelines, because it will not result in a direct or reasonably foreseeable indirect physical change in the environment and is not a "project," as defined in Section 15378 of the CEQA Guidelines.

SECTION 3. Chapter 6.40 is added to the Solana Beach Municipal Code to read as follows:

6.40 REGULATION OF THE SALE AND DISTRIBUTION OF KRATOM

6.40.010 Purpose.

The city council recognizes the inherent danger of kratom products and that the use of kratom products can have devastating health and economic consequences. The city

council further recognizes that kratom may be habit forming and is currently available to people of all ages, including children.

Allowing kratom products to be sold in the city increases access to these harmful and dangerous products. To that end, no kratom products shall be sold or distributed to any person under the age of 21 in the city as is specifically enumerated below.

6.40.020 Definitions.

For purposes of this Chapter, the following definitions shall apply:

"Distribute" or "distribution" means the transfer, by any person other than a common carrier, of a kratom product at any point from the place of manufacture or thereafter to the person who sells the kratom product to an individual for personal consumption.

"Kratom" or "Kratom Product" means the leaf of the plant Mitragyna speciosa or any food product, food ingredient, dietary ingredient, dietary supplement, or beverage intended for human consumption that contains any part of the leaf of the plant Mitragyna speciosa or any extract, synthetic alkaloid, or synthetically derived compound of such plant or its leaf including, but not limited to, any powder, capsule, pill, beverage, or other edible product intended for human consumption.

"Leaf" means any or all parts of the leaf of the plant Mitragyna speciosa that contains mitragynine or 7- hydroxymitragynine.

"Sell," "sale" and "to sell" mean any transaction where, for any consideration, ownership of a kratom product is transferred from one person to another, including but not limited to any transfer or title or possession for consideration, exchange, or barter, in any manner or by any means.

6.40.030 Prohibition on Sale or Distribution of Kratom to Persons Under the Age of 21.

It is unlawful to sell, advertise for sale, offer for sale, or distribute, directly or indirectly, any Kratom Product to any person under the age of 21 in the City.

6.40.040 Posting requirement.

A. A sign with letters of not less than one inch in height shall be clearly, sufficiently and conspicuously posted at the sales counter stating that "Kratom sales are prohibited to

individuals under the age of 21" as controlled by this chapter, by the owner, operator, manager or other person having control of such building or other place.

6.40.050 Enforcement.

A. The city manager, or designee, is authorized to establish regulations and to take any and all actions reasonable and necessary to obtain compliance with this chapter, including, but not limited to, inspecting the premises of any business to verify compliance.

B. Any person, business or retailer violating this chapter shall be guilty of an infraction, which shall be punishable by a fine in accordance with Chapter 1.16 or 1.18 SBMC, or a misdemeanor, which shall be punishable by a fine not exceeding \$1,000, or by imprisonment in the county jail for a period not exceeding six months or by both such fine and imprisonment. In addition to criminal fines, any person, business or retailer violating this chapter shall also be subject to civil penalties or administrative fines or both under Chapters 1.16 and 1.18 SBMC.

C. The city attorney may seek legal, injunctive, or other equitable relief to enforce this chapter.

D. Administrative enforcement of this chapter shall proceed pursuant to Chapter 1.18 SBMC.

E. Each violation of this chapter shall be considered a separate offense.

F. The remedies and penalties provided in this section are cumulative and not exclusive, and nothing in this chapter shall preclude any person from pursuing any other remedies provided by law.

G. Notwithstanding any other provision of this chapter, this chapter may be enforced through any remedy as provided for in this section upon its effective date

6.40.060 No Conflict with Federal or State Law.

Nothing in this chapter shall be interpreted or applied so as to create any requirement, power, or duty that is preempted by federal or state law.

6.40.070 Severability.

If any section, subsection, sentence, clause, phrase, or word of this chapter, or any application thereof to any person or circumstance, is held to be invalid or unconstitutional by a decision of a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions or applications of this chapter. The City Council declares that it would have adopted each section, subsection, subdivision, paragraph, sentence, clause or phrase hereof, irrespective of the fact that any one or more other sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases hereof be declared invalid or unenforceable.

SECTION 4. Severability. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council of the City of Solana Beach hereby declares that it would have adopted this Ordinance and each section, subsection, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more section, subsection, sentence, clause, phrase, or portion thereof, or portion may be declared invalid or unconstitutional.

SECTION 5. This ordinance shall be effective thirty (30) days after its adoption. Within fifteen (15) days after its adoption, the City Clerk shall cause this ordinance to be published pursuant to state law.

SUBJECT:	Awarding Construction Contract for the Highland Drive Median Planting Project

BACKGROUND:

In 2023, the City Council approved construction of median curbs on Highland Drive between Lomas Santa Fe Drive and Uno Verde. During the approval of construction of the median curbs, it was decided that landscaping for the medians would be done as a separate project in the future. The medians were subsequently constructed and are ready to be planted. As part of the Work Plan FY 2024-2025 process, the City Council allocated additional funds for the landscaping and beautification of the subject medians. Staff, with the help of a local landscape architect, prepared construction plans, specifications, and cost estimate for this project and advertised for a competitive bidding process.

This item is before the City Council to consider the adoption of Resolution 2024-105 (Attachment 1) awarding a construction contract to Palm Engineering Construction Company, the lowest responsive and responsible bidder for the Highland Drive Median Planting Project, and to appropriate additional funding for the project.

DISCUSSION:

The median planting was designed by a local Solana Beach resident and construction documents were prepared by City Staff. The median landscaping will be drought tolerant planting without an irrigation system. Other features include granite boulders and a 12-inch-wide concrete perimeter walking area to allow for ongoing maintenance.

The Highland Drive Median Planting Project, Bid No. 2024-10, was prepared and advertised for construction bids. The City received four bid proposals for Bid No. 2024-10. On October 17, 2024, at 10:00 a.m., the City Clerk publicly opened the bids and read them aloud. The bids are listed below in Table 1.

CITY COUNCIL ACTION:

The bid submitted by Palm Engineering Construction Company was found to be complete and responsive to the bid specifications. Palm Engineering Construction Company has successfully performed other projects for the City and Staff is recommending that Palm Engineering Construction Company be awarded the construction contract. The contract amount is based on the City Engineer's estimated unit quantities and the contractor's bid unit prices. The final cost of the project will be based on field measurements and the actual completed quantities. The contract allows 60 working days (12 weeks) to complete the work. The project is anticipated to be started in January 2025 and be completed in March 2025.

CEQA COMPLIANCE STATEMENT:

This project is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301(c) of the State CEQA Guidelines.

FISCAL IMPACT:

The Fiscal Year (FY) 2024/25 Capital Improvement Budget includes the Highland Drive Median Improvements Project funded with \$80,000 in Measure S funding.

In addition to the \$93,782.50 construction contract, Staff is recommending a construction contingency of \$9,000 (approximately 10%) for unanticipated changes, for a total construction budget of \$102,782.50.

As the project cost exceeds the \$80,000 budget, Staff is requesting an additional appropriation of \$23,000 from the Measure S Fund Balance for a total project budget of \$103,000.

WORK PLAN:

This project is consistent with Item B.2 of the Community Character Priorities of the FY 2024/2025 Work Plan.

OPTIONS:
